TE Karen Brown

Karen is currently the chairperson of the Baltimore Presbytery Commission on Reconciliation and Pastor of Hope Presbyterian in Arbutus. Karen was ordained in 1994 in the Baltimore Presbytery as Associate Pastor of Madison Avenue Presbyterian Church. She simultaneously served as the Executive Director of the Madison Avenue Family Life Center, a vital community hub that provided daily services to over 150 families.

Her commitment to justice and reconciliation is evident throughout her service in the Presbytery of Baltimore, where she has served on numerous committees. She currently serves as Co-Convener of the Westside Story Ministry Group, Chair of the Commission on Reconciliation, and a member of Cabinet.

A trailblazer in theological and ecclesiastical leadership, Karen was the founding president of the Union Theological Seminary Black Caucus in 1999 and the inaugural president of the African American Clergy Women's Caucus of the Presbyterian Church (U.S.A.). Her national leadership includes serving as Vice President and board member of the National Black Presbyterian Caucus, Chair of the National Self-Development of People Committee, and currently a member of the Next Generation Initiative of the Synod of the Mid-Atlantic.

Mary currently chairs the Commission on Ministry for Baltimore Presbytery. She transferred her membership from New York City Presbytery following her retirement but then took the position of interim pastor at Faith Presbyterian. She has served as a GA commission from other presbyteries: Orlando (1993) and Syracuse (1997). In previous presbyteries she has served on COM, CPM, Trustees, Property Management and overture advocate for a couple of different Gas. She has often attended GA as an observer and welcomes the opportunity to serve as a commissioner for the first time in 29 years.
