

Minutes of the 891st Gathering of the Presbytery of Baltimore 10:00 am, Thursday, May 13, 2021 Via Zoom Electronic Meeting Platform

OPENING: STORIES AND CELEBRATIONS and WORSHIP.

Moderator Audrey Trapp called the 891st Gathering of the Presbytery of Baltimore, meeting to order via Zoom Electronic platform, on Thursday, March 11, 2021 at 10:05 AM and led in prayer. The call was in order and a quorum was present.

The Moderator called on Stated Clerk, Rev. Mary Gaut, who moved the adoption of the docket as amended by the addendum which had been posted. With a proper second, the motion was APPROVED.

In the absence of Rev. Dr. Jackie Taylor, General Presbyter, who was excused to attend a funeral, the Stated Clerk offered a welcome, and recognized new Teaching Elder, Rev. Glen Misik, Temporary Supply at Babcock Presbyterian and Ruling Elders attending for the first time. She also welcomed Rev. Warren Lesane, Executive and Stated Clerk of the Synod of Mid-Atlantic and a member of Charlotte Presbytery. He was seated as a corresponding member.

The Moderator called on RE Robert Steppling, Chair of the Baltimore Dakota Leaning Camps Steering Committee, who led the Presbytery in acknowledging our commitment to recognizing the Native Americans who occupied the lands of the Presbytery in centuries past.

The Presbytery then moved to Morning Prayer, led by Vice-Moderator Sue Lowcock Harris and TE Morton Harris who serves with Sue as co-pastor of the First Presbyterian Church of Howard Co.

DISCERNMENT AND DECISIONS

Following worship, the Gathering was reconvened with an Update from RE Guy Moody and RE Charese Jordan Moore on the Implementation of the Presbytery's Dismantling Racism policy. Beginning in the Fall of 2021, the Presbytery's Dismantling Racism Team (DRT) will share new opportunities for members, staff and leaders in the Presbytery to meet their continuing education requirements under the Dismantling Racism Training policy. The DRT will offer 2 ways for Teaching Elders, staff and other Presbytery leaders, who have completed the first Dismantling Racism Training, to meet the continuing education requirement. The DRT will use a 10-point scale to assign Continuing Education Units, with 10 units needed every 3 years. Like CEUs in other professions, the amount of credit for a given activity will depend upon the time and investment put into the activity.

- DRT will organize at least one training/program per year. The DRT will assign credits for all of the events it organizes and promotes.
- Individuals can also submit a proposed course or activity for evaluation by the DRT to meet their individual goals.

The Administration Committee recommends:

5. that the Presbytery Manual 7.11.5.1.3 (COM empowerments) be amended to include approval of temporary contracts.

Upon proper second the Consent Motion was APPROVED by common consent.

The Stated Clerk then read the Decision of the PJC 2021-1 (March 26, 2021) as required by D-11.0701. (Appendix E). She prefaced it with a reading from a section of the Preamble of the Rules Discipline (D-1.0101) describing the purpose of Church discipline.

REPORT OF THE GENERAL PRESBYTER

General Presbyter Jackie Taylor, who was excused from the meeting, addressed the presbytery through a pre-recorded video. She titled her remarks "What's in it for you" and addressed some of the ways that the presbytery is supporting congregations as they begin to slowly reopen for in-person gatherings. She referenced a reopening plan crafted by Hope UCC and shared with permission on the POB website as an example of considerations which should guide congregations in their unique circumstances. She also reminded the presbytery of the Covid-relief grants that can be used to assist congregations with changes or improvements to make their buildings safer and better equipped. And she encouraged everyone to get the covid vaccination when they are able.

REPORT OF THE ADMINISTRATION COMMITTEE

Committee Chair, TE John Schmidt, presented three recommended changes to the Trustees section of the Presbytery Manual:

Section 8.7.5.2.2 to read "Presbytery staff compensations are approved, *and the Trustees present an oral report on the content of the audited financial statement for the previous calendar year [Manual 9.5.10]* at the second meeting of the program year. (new text in italics). The motion was APPROVED by common consent.

Replace the wording of Section 9.4 "Authority" with the following (to reflect the language of the Trustees Bylaws, and renumber as 9.2:

The corporate charter grants to the Trustees certain powers.

9.2.1. The corporation may provide in its bylaws for the number, tenure, election, and qualification of the Trustees.

9.2.2 The corporation "shall have the power to pass such rules, regulations or by-laws as shall not be repugnant to any provision of the Constitution or Laws of this State or of the United States;"

9.2.3. The corporation "shall have full power and authority to acquire, take and hold by subscriptions, contributions, legacies, devises or any other method, money or real or personal property, of every kind and description for its said corporate purposes, and the same to invest, and the proceeds to apply for the said corporate purposes as shall from time to time be most expedient;"

9.2.4 The corporation "shall have the right to sell, grant, dispose of, alien or demise all said property in such manner and upon such terms as it shall deem proper."

9.2.5. The corporation is limited in that, "...nothing herein contained shall enlarge, restrict or in any manner affect the power or authority which said Presbytery of Baltimore now hath, or may exercise or claim over the churches in connection with said Presbytery or the members thereof...." The motion was APPROVED by common consent.

Delete Section 9.7 "Funds." (The current description of various funds and fund names in which the Trustees are to hold assets is overly prescriptive, out of date, and has not been the actual practice for quite some time). The motion was APPROVED by common consent.

REPORT OF THE COMMISSION ON PREPARATION FOR MINISTRY

Commission Chair RE Leslie Owsley first called on TE Jack Carlson, chair of the COM Credentials Team, to give an overview of the Book of Order references to commissioning of ruling elders. Commissioning should always be done as a response to a need identified by the Presbytery's mission strategy. He explained that RE Paul Martin, previously ordained in the Roman Catholic tradition but a member of the PCUSA since 1992, has a contract to provide regular preaching and pastoral care at Havre de Grace and that the COM recommended him for commissioning to officiate the sacraments there during the term of his contract as a way to enable the church to celebrate the Lord's Supper regularly in the absence of an installed or interim pastor.

The CPM chair then described the instruction and evaluation which was conducted by the commission which then certified RE Martin to be examined on his faith journey and reason for seeking the commission.

Following his statement and a period of questioning RE Owsley moved that RE Martin be commissioned to officiate the sacraments at Havre de Grace during the term of his contract. The motion did not require a second. After a few questions and affirmations of this process as a way of supporting small congregations, the motion was APPROVED.

RE Owsley then introduced Inquirer Blake Collins for examination on his sense of call. He shared that, as a student at McCormick Theological Seminary, he has partnered with the McCormick Solidarity Building Initiative working with incarcerated persons at Cook Co. Jail. As part of the learning experience, they are reading from the letters of Rev. Dr. Martin Luther King, Jr. who spoke about the difficulty we have of hearing "difficult truths." Blake spoke to the difficult truths he feels the church is called to respond to including the shifting demographics in the church and society, the continued racism and poverty, and the church's own complicity in these. He also expressed his belief that the church is uniquely able to address these issues with messages of grace and love that are transformative, which is why he feels called to ministry so that he may share these gifts which the church is called to offer to the world.

Following a period of questions which included an affirmation of his gifts for ministry RE Owsley moved, on behalf of the CPM, that Inquirer Blake Collins be advanced to candidacy. The motion did not require a second and was APPROVED.

REPORT OF THE COMMITTEE ON REPRESENTATION AND NOMINATIONS

Committee Chair, TE Deborah McEachran placed in nomination the name of Vice-Moderator Sue Lowcock Harris (First Presbyterian of Howard Co.) to be Moderator of Presbytery 2021-2022. The motion did not require a second and was APPROVED. She then placed in nomination the name of RE Cecil Phillips (Dickey Memorial) to serve as Vice-Moderator of the Presbytery 2021-2022. The motion did not require a second and was APPROVED. Biographical statements for both candidates are attached (Appendix F).

NEW BUSINESS:

The chair of the Committee on Representations and Nominations presented an additional candidate for election: RE Betsy Stewart (First of Annapolis) to serve on the Committee on Administration class of 2024. The motion was APPROVED by common consent.

ITEMS PULLED FROM THE CONSENT MOTION: None

There being no further business, without objection, the meeting was closed with prayer by the Vice-Moderator, Rev. Sue Lowcock Harris and adjourned by the Moderator.

APPENDIX C: Report of the Dismantling Racism Team

Dismantling Racism Continuing Education Update to Commission on Reconciliation May 13, 2021

Beginning in the Fall of 2021, the Presbytery's Dismantling Racism Team (DRT) will share new opportunities for members, staff and leaders in the Presbytery to meet their continuing education requirements under the Dismantling Racism Training policy. Learning and working to dismantle racism can happen in many ways. In addition to organizing our own events, there are a number of Presbyterian offices and other faith-based organizations offering excellent conferences, workshops and other opportunities that are consistent with the Presbytery's goals.

The DRT, therefore, will offer 2 ways for Teaching Elders, staff and other Presbytery leaders, who have completed the first Dismantling Racism Training, to meet the continuing education requirement. The DRT will use a 10-point scale to assign Continuing Education Units, with 10 units needed every 3 years. Like CEUs in other professions, the amount of credit for a given activity will depend upon the time and investment put into the activity.

- DRT will organize at least one training/program per year. The DRT will assign credits for all of the events it organizes and promotes.
- Individuals can also submit a proposed course or activity for evaluation by the DRT to meet their individual goals.

Here are the educational opportunities that the DRT is currently planning:

- Dismantling Racism Part-2 Workshop and Support for Pastors & Congregational Leaders (Organized by DRT into 2 sessions) - 10 credits – delve more deeply into specific skills and resources for the work of dismantling racism within your congregation. Participants will be asked to present work they are doing in their own context. The workshop will take place in two sessions to allow time for reflection and practice.
- Dismantling Racism Affinity Group Meetings for People of Color Only (3 meetings minimum organized by DRT) - 10 Credits. DRT members are in the early planning stages for this facilitated group experience for African American pastors and congregational leaders.
