Minutes of the 893rd Gathering of the Presbytery of Baltimore 10:00 am, Thursday, October 21, 2021 Via Zoom Electronic Meeting Platform

OPENING: STORIES AND CELEBRATIONS and WORSHIP.

Moderator Sue Lowcock Harris called to order the 293rd Gathering (Stated Meeting) of the Presbytery of Baltimore, on Thursday, October 21, 2021, at 10:00 AM and led in prayer. The call was in order and a quorum was present.

She called on the Stated Clerk, Mary Gaut, who moved the adoption of the Docket. It was seconded and **APPROVED** by common consent.

General Presbyter, Jackie Taylor, welcomed first time ruling elders and new minister member of the Presbytery, Alison Paden Peters, pastor of First Cumberland Presbyterian.

RE Bob Steppling, chair of the Dakota Partnership, introduced a video presentation remembering the indigenous peoples who once occupied the geographical area of the presbytery.

The moderator called on TE Amy Carlson to share what will be new at Triennium in 2022 and why the offering at this meeting will be designated to offset the costs. The Presbytery was then called to worship. Guest preacher Avery Davis Lamb, co-Executive Director of Creation Justice Ministries, spoke of the importance of the church addressing Climate Change, reminding those gathered that we don't have to be scientists to talk about the threats with integrity as people of hope. The sacrament of the Lord's Supper was celebrated. Rev. Jackie Taylor and Rev. Morton Harris were co-celebrants.

DISCERNMENTS AND DECISIONS

Following worship, the presbytery moved into Discernments and Decisions.

Stated Clerks Report and Consent Motion

The Stated Clerk reported that no items had been removed from the consent motion (items 2-4) and moved that it be approved:

- 2. That the Minutes of the 892nd Gathering be approved.
- 3. That the specialized ministries listed with the meeting papers be validated for the 2022 calendar year. (See Appendix B)
- That the following be elected to the positions indicated: For the Nominating Committee, Class of 2022: RE Lynn Carlson (Highland) For the Commission on Preparation for Ministry, Class of 2024: TE Richard Jones (Annapolis)

For the Thriving Congregations Commission, Class of 2023: RE Tina Coleman (Harundale)

The Motion was seconded and **APPROVED** by common consent.

Report of the Nominating Committee (See Appendix C)

The Moderator recognized TE Deborah McEachran. She moved that the following persons be elected as Baltimore Presbytery Commissioners to the 225th General Assembly which will be a hybrid assembly:

TE Billy Kluttz (Govans), TE Barbara Renton (HR), RE Keith Reagan (Christ Our King), RE Audrey Trapp (Faith).

That TE Jacob Snowden be elected a Teaching Elder alternate,

That Gayelle Sama (St John United) be elected as Young Adult Advisory Delegate.

There were no nominations from the floor, and all were **ELECTED** unanimously.

Report of the Administration Committee (See appendix D)

Chairperson, TE John Schmidt, moved the approval of the 2022 Staff Compensations as posted in the meeting papers. Following discussion related to whether the salaries were equitable, the motion was restated by the chairperson at the request of the Moderator and was **APPROVED** with two opposed.

TE Shannon Weston moved that the issues of equity in staffing be referred to the Personnel and Administration committees and that they report back to the presbytery at the March stated meeting. The motion was seconded and APPROVED with one opposed.

Overture from Ashland Presbyterian (See Appendix E)

The Moderator recognized TE Shannon Weston who moved the following from the Ashland Presbyterian Session, that:

The Presbytery of Baltimore overtures the 225th General Assembly to change the use of the term "AIDS" to "HIV" in all national awareness days recognized on the Presbyterian Planning Calendar. Following a second, permission to speak to the motion was given to Derrick Weston, co-chair of the Presbyterian HIV network. The overture was APPROVED.

Reconsideration of the Administration Committee report

RE Guy Moody was recognized and moved that the approval of staff salaries be reconsidered. The Stated Clerk ruled the motion out of order since he had voted with the minority. RE Bill Sheridan, who voted with the majority, moved reconsideration and the motion was seconded. The motion to reconsider was APPROVED with 28 voting for and 18 against.

During discussion, members of presbytery were encouraged to send specific concerns to the Personnel Committee. The Moderator brought item #9 back to the presbytery (as it was being

reconsidered): the approval of the 2022 staff salaries as posted in the meeting papers. The motion was APPROVED with 23 voting in favor and 2 opposed.

Report of the General Presbyter

Jackie reported on insights gleaned from the Mid-Council leaders conference she attended October 4-7.

The Stated Clerk reported that there was no new business.

STORIES AND CELEBRATIONS (continued)

The Nov. 1, 2021, retirement of the Rev. Dr. Terrence Alspaugh, pastor of Granite Presbyterian, was recognized. RE Michael Kahn, clerk of session at Granite, gave an overview of Rev. Alspaugh's career and offered appreciation for his leadership. Rev. Alspaugh charged the Presbytery to be the Body of Christ in the world.

Moderator Sue Lowcock Harris adjourned the meeting at 12:38PM. Vice-Moderator, Cecil Phillips offered a closing prayer.

RULING ELDERS

Keith Reagan (Christ our King):

I am honored to be considered as a nominee for the position of ruling elder commissioner to the 2022 General Assembly. Our family moved to Bel Air from Germany in 2014, becoming members of Christ Our King PC(USA) shortly after arriving. I was asked in late 2017 to consider serving on the Session of Christ Our King and started my term in January of 2018. I was elected to serve as Clerk of Session in April of that year. As Christ Our King had no procedure for projecting income, I established an annual pledge-based stewardship campaign and remained campaign chair for four years. I have served in the Session ministries of Finance, Facilities, Missions, and Personnel. Such an opportunity as this to serve at the highest levels of the denomination is rare indeed and it is important that Christ Our King continues to learn of the

importance of being part of a connectional denomination in which we undergo ministry and decision making together as a unified Presbyterian body. Having been offered this opportunity to participate in this process, I consider this service an important and necessary duty to serve my church, my presbytery, and my denomination.

Audrey Trapp (Faith):

A life-long Presbyterian, I have been an active member and RE at Faith Presbyterian Church for almost 40 years. I am the immediate past Moderator of the Presbytery of Baltimore and the current Chair of the Steering Cabinet. I served on the Commission on Reconciliation and Cochaired the Hospitality Committee of the Committee on Local Arrangements for the 2020 General Assembly. Involved with the Cuba Partnership for many years, I currently serve on the Steering Committee of the national Cuba Partners Network.

An advocate for equity and justice, I believe that the PC(USA) has important work to do to ensure that our denomination welcomes and affirms all people and atoms for our past failures to treat all as our sisters and brothers in Christ.

I look forward to serving as a commissioner to the 225th General Assembly and, if elected, I will be a faithful and dedicated Commissioner, with your prayers and God's help.

TEACHING ELDERS

Barbara A. Renton, Honorably Retired (Catonsville)

A graduate of Princeton Seminary, I served churches of all sizes in Long Island and Southern New England presbyteries and have served as Executive Presbyter in Susquehanna Valley Presbytery. After retirement, I continued to do interim and temporary supply service in congregations there until moving to Baltimore Presbytery where I have served on one short-term committee and am now on the Reconciliation Commission.

Why do I want to serve? I find that events long felt in the local congregations have strongly impacted the service and organization of the national offices in Louisville. As a founding member of the Czech Mission Network and a participant in the Ethiopian Mission Network, I have struggled with the seemingly constant changes in support services. A new structure and style of support for mission has been proposed – I want to offer my support and/or ask the questions that need to be asked on behalf of presbyteries and congregations.

Rev. Billy Kluttz works as associate pastor at Govans Presbyterian Church and serves on the Thriving Congregations Commission for the Presbytery of Baltimore. Prior to his current call, Billy served calls at Immanuel Presbyterian Church, Church of the Covenant, and The New York Avenue Presbyterian Church in National Capital Presbytery. While in National Capital Presbytery, Billy served on the presbytery's Worship and Theology Committee (2017-2020) and as a board member of the DC Young Adult Volunteer Program (2019-2020). PROPOSED OVERTURE COMING FROM THE ASHLAND PRESBYTERIAN SESSION

The Presbytery of Baltimore overtures the 225th General Assembly to change the use of the term "AIDS" to "HIV" in all awareness days recognized on the Presbyterian Planning Calendar. This change would be made only on national awareness days, not international.

Rationale:

The continued use of the term "AIDS" is problematic for several reasons. First, it underlines a continuing misunderstanding of the issue. HIV is the virus. AIDS is the result of the virus causing severe damage to the immune system. Second, due to improvements in medical treatment, complications due to HIV are far more prevalent than AIDS itself. Language should be adjusted to reflect the current realities of the disease. Finally, the term "AIDS" continues to be both misunderstood and stigmatizing. Medical professionals have favored using the term "Stage 3 HIV" over "AIDS" in current work largely due to the stigma associated with the latter term (www.nih.hiv.gov)

The continuing stigmatization of HIV is made even more problematic by who is suffering from the virus. Black and Latinx members of the LGBTQ community are disproportionately being affected by the disease. HIV remains at epidemic levels in many black and brown communities throughout the nation because they are disproportionately affected by poverty (www.hiv.gov/hiv-basics/overview/data-and-trends/statistics). The PC(USA) should be working to lift the veil of misinformation and working to improve the social determinants of health for those at the margins.

Despite the dire circumstances that exist where the virus spreads, using the term HIV should serve as a reminder that the virus is no longer the death sentence it once was. People are living and thriving with HIV and are actively contributing to their churches and their communities. This change honors their perseverance and integrity. Additionally, the Church should adopt the stance of using "people first language" whenever it is appropriate, to focus on the people rather than just being aware of it. For example, when referring to awareness days, we would say "People Living With HIV (PLWH) Day" rather than "HIV Awareness Day."

The Presbyterian AIDS Network (PAN) recently changed its name to the Presbyterian HIV Network (PHIVN). This was done with the above factors in mind. We believe that all official communication from the PC(USA) should replace "AIDS" with "HIV" and that the Church continues to educate itself on this ongoing epidemic. The PC(USA) should position itself to be an active part of the <u>ending the epidemic plan</u> set out by the Centers for Disease Control and Prevention.

The ongoing COVID pandemic dramatically shifted the work of the Commission on Spiritual Leader Development again over the course of the past months. The Commission made the difficult decision *not* to host a clergy and/or family retreat for a second year in a row as concerns about the Delta variant and the lack of vaccinations for children under the age of 11 continued to rise over the late spring and summer. Instead, the Commission is excited to announce that part of that funding will be used to hire a facilitator for a clergy Bible Study, which will be held online via zoom.

The Commission was relieved to learn that Triennium *will* continue next summer for youth. It will be held at the Indiana Convention Center rather than at Purdue University, and it is a slightly shorter conference than it has been previously. The planning team, however, is

working with The Center to add a local component that will help build relationships between youth here in the Presbytery. Stay tuned for more information!

Much of the funding that SLD oversees is earmarked for scholarships - a significant portion of which is to support church leaders (not just pastors!) who want to attend continuing education events. The Commission merely asks that those who receive scholarships for such events come up with creative ways to share what they learn with the rest of the Presbytery. Additionally, funding is available to offset the cost of coaching.
