## Minutes of the 897<sup>th</sup> Stated Meeting of the Presbytery of Baltimore

### November 12, 2022 at 10:00 am Virtual Meeting via Zoom

#### STORIES AND CELEBRATIONS

Vice-Moderator, Andrew Connors, called the meeting of the Presbytery of Baltimore to order at 10:04 AM. He opened the meeting with prayer. A quorum was present. Vice-Moderator Connors presided at the entire meeting in the absence of Moderator Cecil Phillips who was attending the denominational Moderators' Conference in Louisville, Ky.

He called on the Stated Clerk, Mary Gaut who moved the adoption of the Docket. It was seconded and APPROVED by common consent.

General Presbyter, Jackie Taylor, welcomed first time ruling elders and guests and offered a particular welcome to Certified Christian Educator, Kathryn Woods, who is a new staff member at Woods Memorial.

A video was shown to remember the Native Peoples who once occupied the land within the bounds of our presbytery. Such a remembrance is done at each meeting of the presbytery.

Rev. Catherine Goodrich, pastor of Faith, gave a report on the experience of the Peaceful Resolutions conflict resolution training. She emphasized that conflict is real and that the numbers of Presbytery members becoming trained in this important work is a cause for celebration.

The Presbytery then moved into a time of Worship.

#### **DISCERNMENETS AND DECISIONS**

#### STATED CLERK'S REPORT AND CONSENT MOTION

The Moderator called upon the Stated Clerk who presented the consent motion. (see Appendix B) She reported that a member had requested that item #6, the approval of amendment 22-BB be pulled from the motion. The amended motion included the approval of the minutes of the 896<sup>th</sup> stated meeting and Book of Order proposed amendments 22-A, AA, B, V, W, X, Y, Z. The motion was seconded and **APPROVED** by common consent.

She then presented proposed amendment 22-T to amend W-3.0205 which adds administration of the sacrament of Baptism to the list of appropriate actions following the proclamation of forgiveness in a service of worship. The motion was **APPROVED** 

Proposed amendment 22-U to amend W-3.0409 adds "when appropriate" to the recommended act of providing an invitation to baptismal preparation for those who come to the table who are unbaptized was presented and was **APPROVED**.

#### REPORT OF THE COMMISSION ON PREPARATION FOR MINISTRY

The moderator recognizes Rev. Catherine Goodrich, a member of the Commission on Preparation for ministry. Rev. Goodrich moved, on behalf of the commission, that candidate Nicole Reibe be examined on her statement of faith (Appendix B) and be certified ready to receive a call. Following the examination the candidate was moved to the waiting room. The motion to be certified ready to receive a call was APPROVED. Dr. Reibe was brought back from the waiting room to applause and Rev. McKenna Lewellen offered a prayer

Rev. Goodrich then moved, on behalf of the commission, that candidate Blake Collins be examined on his statement of faith (Appendix C) and be certified ready to receive a call. Following the examination, the candidate was moved to the waiting room. The motion to be certified ready to receive a call was APPROVED. Mr. Collins was welcomed back with applause and Revs Morton Harris and Sue Lowcock Harris jointly offered a prayer of blessing.

Finally, Rev. Goodrich moved on behalf of the commission that inquirer Carroll Fitzgerald be examined on his sense of call and be moved to candidacy status. Follow his examination he was moved to the waiting room and the motion was APPROVED. He was returned from the waiting room and affirmed with applause. Rev. Edwin Lacy offered a prayer.

#### REPORT OF THE GENERAL PRESBYTER

General Presbyter Jackie Taylor, read from Haggai 2 which predicts that the rebuilt temple would be more wonderful than the old. She said that in this "post crisis covid time" many things still are not the way they were and never will be. Quoting from Davis that as we go through a constant cycle of hope and disappointment, our work is to reimagine what it means to be community and that churches in Baltimore Presbytery and the Presbytery itself is doing this faithfully.

#### REPORT OF THE COMMITTEE ON REPRESENTATION AND NOMINATIONS

RE Lynn Carlson, member of the Committee, was recognized. She moved, on behalf of the Committee, that Presbytery elect to the Commission on Reconciliation class of 2025, representing the Guatemala Partnership RE Jane Hauck (Govans), class of 2025, to the Trustees class of 2025, RE Brooke Schumm (Mt. Hebron), and to the Commission on Preparation for Ministry class of 2025 Rev. Michael Cuppett (Validated Chaplaincy). The moderator called for nominations from the floor and Rev. Michael Ward (Brown) was nominated to the Property and Loan Commission class of 2025. The amended slate of nominees was APPROVED. She reported on continuing vacancies and urged people to consider if they may be called to serve in one of those positions or knew others who should be considered.

#### REPORT OF THE COMMISSION ON MINISTRY

Rev. Jack Carlson, chair of the Credentials Team of the COM was recognized. He moved that the position of Senior Consultant and Lead Trainer for Unburdened, Inc., developed and held by Rev. Shannon Weston, be approved as a validated ministry. The motion did not require a second. Rev. Weston spoke briefly about her ministry in this capacity and the motion was APPROVED.

Rev. Carlson then moved that the position of staff attorney, Post-Conviction Relief Unit of the First Judicial District, Court of Common Pleas of Philadelphia County, held by Rev. Tanya Denley, be approved as a validated ministry. Rev. Denley spoke about the nature of her work as a ministry. She was then moved to the waiting room. Following discussion the motion to validate the ministry was **APPROVED**.

#### REPORT OF THE ADMINISTRATION COMMITTEE:

The Moderator called on Rev. John Schmidt for the report of the Administration Committee. He moved the 2023 Staff Compensation Budget (Appendix D) be approved. The motion did not require a second. Following discussion and questions of clarification about the nature of some unfilled positions, the motion was **APPROVED**.

#### REPORT OF THE COMMISSIONER TO THE SYNOD OF MID-ATLANTIC

CRE Ed Terry was recognized to report on the recent synod assembly which met September 12-13 at Massanetta Springs. The Synod continued its focus on the Matthew 25 emphasis on serving the poor among us. Commissioners were asked to report on an innovative ministry in their presbytery and he shared our creation of the position of Staff Interim that is able to help small congregations during periods of transition.

#### ITEM PULLED FROM THE CONSENT AGENDA

The Stated clerk reported that the request to pull proposed amendment 22-BB from the consent agenda was to enable clarification about whether a particular word was being stricken or retained. Susan Moody moved that consideration of the item be postponed until the next stated meeting. The motion was seconded and APPROVED.

There was no new business. Upon a motion and second, the meeting was **ADJOURNED** by the Moderator at 12:25PM and closed with prayer by Rev. Janine Zabriskie, chaplain at University of Maryland Hospital.

## APPENDIX B Nicole Reibe Statement of Faith

I believe in the Trinity, made up of God the Father, Jesus the Son, and the Holy Spirit. They are three in one; where one is all three are. While the internal life of the Trinity is a mystery, we have some trace of it by the creating, redeeming, and sustaining actions of the Trinity done on behalf of all creation. God is goodness, truth, and beauty. I believe that God created the universe and all that is in it. As Lord of all creation, God is sovereign and providential. Humans bear the image and likeness of God through their rational and social nature. Regardless of gender, race, ethnicity, sexual orientation, relationship status, or ability, all are loved by God, and all can use their unique gifts to praise and glorify God and serve others. The rest of creation, as God's divine work, reflects God's grandeur, bears witness to God's abiding goodness, and ought to be respected, cared for and preserved.

Jesus is the incarnate second person of the Trinity. He was born of the Virgin Mary and is fully human and fully divine- two natures in one divine person. Through Christ's incarnation, ministry of love, death on the cross and resurrection, he reconciled all of creation to God and to each other. His example of holiness and solidarity continues to inspire his followers to ally themselves with the marginalized and forgotten in society, to provide for bodily and spiritual needs, and to risk persecution for the sake of the inbreaking of God's kingdom. He was raised three days later and appeared to his disciples, encouraging them to continue his ministry. Christ's resurrection is a harbinger of the general resurrection when all creation will be renewed, and peace will reign. He then ascended into heaven and sent the Holy Spirit at Pentecost.

The Holy Spirit empowers Christians to do God's work while on earth. The Holy Spirit is the third member of the Trinity and is present with us here and now. The Church is made up of all Christians in all times and places and is Christ's body and representative on earth. The Church is led by Christ and held together by the Holy Spirit. Scripture, as a whole, gives expression to God's relationship with humanity, and proclaims the everlasting and irrevocable covenant with the Jewish people, through which all the nations of the world will be blessed. I believe that the gospel includes the good news of Christ's eternal salvation, but also that there is hope for peace in this world. Scripture has a surplus of meaning, and interpretation of Scripture is led by the Holy Spirit for the particular community and in concord with tradition and reason. The people of the Church proclaim the coming Kingdom of God by showing God's love to the world through acts of justice, peace building, and reconciliation. Christians relate to the world through open engagement, not by isolating themselves into Christian enclaves; by having a willingness to have our ideas stretched as we encounter new contexts; and by trusting that God is with us and leads us through all situations.

Humanity is reminded of God's love for them through the sacraments. The sacrament of baptism is a sign and seal of God's election of individuals from before the beginning of time through God's free and radical grace. In the celebration of the Lord's Supper, Christ is spiritually present in the wine/grape juice and bread. The sacrament calls the congregation to remember the cross and strengthens and encourages them to continue Christ's ministry in the world.

### **APPENDIX C Blake Collins Statement of Faith**

Statement of Faith Blake A Collins

In the beginning, God created the heavens and the earth. God loves creation and claimed everything created as good. Our Creator is a Triune God whose very being reveals a free and perfect love that exists for the Other. God is so committed to freedom and the other that God granted humanity free will. Although humanity falls short of it, God's will remains perfect and mysterious in its full purpose. God reveals this purpose through inspired Scripture, prophets, poets, artists, the ordinary, the extraordinary, and God's own self, who appeared in flesh as Jesus Christ.

> Jesus the Christ is the full manifestation of God, being fully-human and fully-God. Christ's life on earth always aligned with God's will. Christ was with God from the beginning and therefore echoed the knowledge that everything created is good; Christ's life and ministry exemplified this truth. As one whose earthly experience occurred in the margins, Jesus confronted both individual and corporate sin while on earth. Jesus condemned systems and structures that harmed and restricted life. Christ's love was not passive to oppression but actively resistant. Christ aggressively crossed boundaries, both physical and cultural, to proclaim God's kin-dom for all. In line with his Jewish faith tradition, Christ taught the radical act of remembrance: remember that God is good, remember that we are created in God's image, and remember because God loves us, we must love one another. As a witness to love, liberation, and life, Jesus participated in the suffering of the world. Because of Christ's holy teachings, he was crucified by earthly powers and died on the cross. Christ's death was a protest to death; Jesus is risen. God's resurrection claims life will have the final word and sent an Advocate to remind us

The Holy Spirit is present and active in the world. God's Spirit encourages, affirms, restores, heals, inspires, and co-creates. God, Jesus, and the Spirit are three in one. Wherever one is present, all are present. As such, God invites the Church to work as God exists: in community. God's work in the world through God's Church is therefore prophetic and necessary because God calls the Church to co-labor with God, giving particular attention to the ill, the imprisoned, the ignored, and the actively disenfranchised.

30 The Church, like scripture, consistently urges all to remember God's works, to love one's 31 neighbor, and to exemplify God's abundant love. The Church, while divinely inspired, is a 32 human institution. Like humanity, it is complex and imperfect, but remains inspired by Christ 33 and reconciled to God. Like God's movement in the world, the Church's work must always be relevant, inclusive, and liberating. God calls God's Church into this work through baptism, 34 35 reminding us that we are wonderfully made, called, and loved. God continually urges the Church to become new creations in Christ, liberated from sin and free for one another. Communion exemplifies God's abundance and mercy which extends beyond time and space. The elements of communion and the waters of baptism implore God's people to resist temptations of division, 38 39 fear, and scarcity. God's sacraments are a reminder of God's grace. God's Church, through Christ's teachings and empowered by the Holy Spirit, remains called to invite in and act from 41 love by remembering, worshipping, working and collaborating with our neighbor, who like us, is created in God's image.
