The number of ruling elders enrolled in the membership of presbytery in 2022 exceeds the number of enrolled ministers and therefore no additional elders from congregations are needed.

Steering Cabinet

At its most recent meeting (4/26/2023), the Steering Cabinet continued to work on implementing the new strategic priorities of the presbytery:

- \cdot strong, sustainable, resourced congregations.
- \cdot an inclusive, just organization where all have equal voice and access.
- · an energized, adaptive presbytery, ready to witness to the movement of the Spirit.
- \cdot healthy pastors with resources for spiritual, mental and emotional health.
- \cdot a culture of coaching and learning for clergy and lay leaders.

We discussed potential new models for presbytery team ministries, and heard proposals about interesting new initiatives including a strategic plan to support the work and ministries of small congregations, and a proposal for a Leadership Academy for Pastors and Congregations. The Cabinet also continued its discernment about the way presbytery can best act to encourage, challenge and equip leaders and congregations in the areas of youth and young adults and community engagement in the next decade. Cabinet will recommend to Presbytery at its September 16th meeting the removal of The Center as an entity of the Presbytery and make all required changes to the manual to facilitate this move. Congregations will receive a communication from Steering Cabinet with a more detailed look at this action this summer. We celebrate what we as a presbytery have learned from the years of our partnership with The Center, and we look forward to deepening and broadening our commitment to youth, young adults and community engagement across the Presbytery of Baltimore in the future.

2. Vice-Moderator (2023-2024): RE Soung Hee Baranowski (Havre de Grace)

Soung Hee was born and raised in Seoul, South Korea. She grew up influenced by Confucianism and Buddhism. In Korean culture, it was believed that many sons (and not daughters) brought many blessings to the family. Soung Hee writes: "I was born the third daughter among four girls and my parents only had one son. I wasn't very welcome at birth. Despite my background, I went to middle school, high school and college founded by Christian missionaries. From the seed that was planted, I became a Christian after I immigrated to America in 1979.... I tried so hard not to be burden to my parents. I wanted to be strong, smart and independent like a son. But I was wounded, fragile and lonely.

The first time I heard the voice of God was during the first Bible study at my house in 1985. "Ask and it will be given to you; seek and you will find; knock and the door will be opened." (Matthew 7:7) When I heard that voice, I knew it was God because nobody knew I needed help. Immediately, I asked God to forgive my sin and I accepted Jesus for my Savior. It was a miracle that I was a sinner before and now I became a righteous one."

Her parents wished for a boy, not a girl. She came to America following the American dream to be rich, and yet became a follower of Jesus. She says: "It wasn't my plan but God's plan. I did not have any idea to be a Vice-Moderator... and now I am. Always his plan, not mine. I trust his plan to prosper us and give us hope and a future for Baltimore Presbytery." (Jeremiah 29:11) Soung Hee retired from her own insurance business in 2017 and has four grandchildren aged 12 years to 1 month. She is a ruling elder at Havre de Grace Presbyterian Church.

3. Moderator 2023-2024: TE Andrew Connors (Brown Memorial)

Andrew Connors has been Senior Pastor at Brown Memorial Presbyterian Church since 2004. From 2010-2021 he served as clergy co-chair of Baltimoreans United in Leadership Development (BUILD), a local affiliate of the Industrial Areas Foundation (IAF) and Maryland's largest citizen's power organization. One of the founders of NEXT Church, a national movement among Presbyterians excited about the future of the Presbyterian Church (USA), he has also served as co-chair. He serves on several nonprofit boards and is a frequent contributor to journals and commentaries. Andrew holds degrees from Duke University and Columbia Theological Seminary and was the 2001 recipient of the David H.C. Read Preaching Award.

Commission on Ministry

The Commission on Ministry reports

At its March 29 Leadership Team meeting:

Approved the request of Hunting Ridge Presbyterian Church for the use of its sanctuary by the Evangelical Baptist Church, Maryland, an independent congregation serving an immigrant community, and referred the action to the P&L commission for final approval. <u>At its May 3 meeting</u>:

Approved the retirement of Rev. Kerry Slinkard effective 4/1/2019 (retroactive to correct an administrative omission because he was transferring from another presbytery at that time). Approved Dismissing Rev. Billy Klutz to National Capitol Presbytery 05/03.2023

Reminds congregations that leasing sanctuary space to another worshipping community or congregation requires the approval of the COM and the Property and Loan Commission. All long-term leases of any space (five or more years) also require the approval of the Property and Loan Commission. (G-4.0206b)
