Minutes of the 899th Stated Meeting of the Presbytery of Baltimore

May 11, 2023, at 10:00 am Virtual Meeting via Zoom

Moderator, Cecil Phillips, called the meeting of the Presbytery of Baltimore to order at 10:04 AM. He opened the meeting with prayer. A quorum was present. He gave a detailed explanation of the process for seeking recognition on the "floor" and for voting.

He called on the Stated Clerk, Mary Gaut who moved the adoption of the Docket. It was seconded and APPROVED by common consent.

General Presbyter, Jackie Taylor, welcomed first time ruling elders and guests including Rev. Susan Boucher from Denver Presbytery. She moved that Rev. Boucher be seated as a corresponding member. The motion was seconded and **PASSED** by common consent.

RE Bob Steppling invited the presbytery to remember the Native Americans on whose land we reside in accord with our standing rule to begin each meeting with such a remembrance.

Commissioned Ruling Elder Ed Terry was recognized to give a report on the 221st meeting of the Synod of the Mid-Atlantic, emphasizing the Matthew 25 initiatives that were shared. He reported that Rev. Carlos Wilton, also a Synod commissioner, shared information on the partnership between Govans and Knox Presbyterian.

The Moderator then called on Rev. Carl Wilton, to present the Synod Small Church Grant of \$5,000 to Hamilton Presbyterian. The grant was awarded by the Synod to help with the costs of floor replacement in the church.

The Presbytery then moved into Morning Devotions planned by the Commission on Thriving Congregations. It introduced the practice of Visio Divina, reflection on the pairing of the reading of the story of Nicodemus (John 3:1017) with a work of art titled *Renacimiento* by Carmelle Beaugelin.

STATED CLERK'S REPORT AND CONSENT MOTION

Following devotions, the Moderator called upon the Stated Clerk who presented the consent motion. The motion included the approval of the minutes of the 898th stated meeting and Book of Order proposed amendments 22-DD, 22-EE and 22-FF. No motions were removed from the consent motion, and it was seconded and **APPROVED** by common consent.

She moved GA proposed amendment 22-CC to amend D-3.0106 which was APPROVED.

She then moved GA proposed amendment 22-GG which would replace the current "Rules of Discipline" with a new section "Church Discipline. This amendment was also **APPROVED**.

REPORT OF THE COMMITTEE ON REPRESENTATION AND NOMINATIONS:

Rev. Deborah McEachran, chair of the committee, was recognized by the moderator. She moved that the slate of commission and committee members, as presented in the committee report, be approved. The motion did not require a second and there were no nominations from the floor. The motion was **APPROVED**.

She moved that Ruling Elder Soung Hee Baranowski (Havre de Grace) be elected Vice-Moderator for the program year 2023-24. There were no nominations from the floor and the motion was **APPROVED**. (Elder Baranowski was not present).

Finally, she moved that Rev. Andrew Connors (Brown Memorial) be elected Moderator for the program year 2023-24. There were no nominations from the floor and the motion was **APPROVED**.

The Moderator turned the gavel over to the Vice-Moderator, Andrew Connors.

REPORT OF THE COMMISSION ON MINISTRY

Rev. Mary Speers, chair of COM was recognized. She moved that the position of Assistant Theology Professor/Director of Theology Graduate Program at Loyola University be approved as a validated ministry. The motion did not require a second. After a brief explanation of Validated Ministries, the motion was **APPROVED**.

Rev. Speers then moved that Candidate Nicole Reibe be examined on her sense of call to the validated ministry at Loyola University and, if sustained, that she be approved for ordination. Following a brief period of questions, Dr. Reibe was moved to the waiting room. The motion was **APPROVED** as presented. Dr. Reibe was returned from the waiting room and a prayer of blessing was offered by Rev. McKenna Lewellen, pastor of Maryland Presbyterian Church.

REPORT OF THE GENERAL PRESBYTER

Rev. Jackie Taylor was recognized by the Moderator for her report. She spoke about the values of the Presbytery as identified in the strategic planning process: Promoting Justice, Practicing Inclusivity, and Prioritizing Churches and Leaders to Thrive.

The gavel was returned to Moderator RE Cecil Phillips.

There was no old or new business. The meeting was **ADJOURNED** at 11:39AM and closed with prayer by Rev. Jackie Taylor.

APPENDIX C

Steering Cabinet

At its most recent meeting (4/26/2023), the Steering Cabinet continued to work on implementing the new strategic priorities of the presbytery:

- · strong, sustainable, resourced congregations.
- · an inclusive, just organization where all have equal voice and access.
- · an energized, adaptive presbytery, ready to witness to the movement of the Spirit.
- · healthy pastors with resources for spiritual, mental and emotional health.
- \cdot a culture of coaching and learning for clergy and lay leaders.

We discussed potential new models for presbytery team ministries, and heard proposals about interesting new initiatives including a strategic plan to support the work and ministries of small congregations, and a proposal for a Leadership Academy for Pastors and Congregations. The Cabinet also continued its discernment about the way presbytery can best act to encourage, challenge and equip leaders and congregations in the areas of youth and young adults and community engagement in the next decade. Cabinet will recommend to Presbytery at its September 16th meeting the removal of The Center as an entity of the Presbytery and make all required changes to the manual to facilitate this move. Congregations will receive a communication from Steering Cabinet with a more detailed look at this action this summer. We celebrate what we as a presbytery have learned from the years of our partnership with The Center, and we look forward to deepening and broadening our commitment to youth, young adults and community engagement across the Presbytery of Baltimore in the future.

2. Vice-Moderator (2023-2024): RE Soung Hee Baranowski (Havre de Grace)

Soung Hee was born and raised in Seoul, South Korea. She grew up influenced by Confucianism and Buddhism. In Korean culture, it was believed that many sons (and not daughters) brought many blessings to the family. Soung Hee writes: "I was born the third daughter among four girls and my parents only had one son. I wasn't very welcome at birth. Despite my background, I went to middle school, high school and college founded by Christian missionaries. From the seed that was planted, I became a Christian after I immigrated to America in 1979.... I tried so hard not to be burden to my parents. I wanted to be strong, smart and independent like a son. But I was wounded, fragile and lonely.

The first time I heard the voice of God was during the first Bible study at my house in 1985. "Ask and it will be given to you; seek and you will find; knock and the door will be opened." (Matthew 7:7) When I heard that voice, I knew it was God because nobody knew I needed help. Immediately, I asked God to forgive my sin and I accepted Jesus for my Savior. It was a miracle that I was a sinner before and now I became a righteous one."

Her parents wished for a boy, not a girl. She came to America following the American dream to be rich, and yet became a follower of Jesus. She says: "It wasn't my plan but God's plan. I did not have any idea to be a Vice-Moderator... and now I am. Always his plan, not mine. I trust his plan to prosper us and give us hope and a future for Baltimore Presbytery." (Jeremiah 29:11) Soung Hee retired from her own insurance business in 2017 and has four grandchildren aged 12 years to 1 month. She is a ruling elder at Havre de Grace Presbyterian Church.

3. Moderator 2023-2024: TE Andrew Connors (Brown Memorial)

Andrew Connors has been Senior Pastor at Brown Memorial Presbyterian Church since 2004. From 2010-2021 he served as clergy co-chair of Baltimoreans United in Leadership Development (BUILD), a local affiliate of the Industrial Areas Foundation (IAF) and Maryland's largest citizen's power organization. One of the founders of NEXT Church, a national movement among Presbyterians excited about the future of the Presbyterian Church (USA), he has also served as co-chair. He serves on several nonprofit boards and is a frequent contributor to journals and commentaries. Andrew holds degrees from Duke University and Columbia Theological Seminary and was the 2001 recipient of the David H.C. Read Preaching Award
