Steering Cabinet

The Steering Cabinet reports that

At its meeting on September 24, 2025, at the request of the Commission on Ministry it approved an

ADMINISTRATIVE COMMISSION FOR LOCHEARN PRESBYTERIAN [G-3.0109b(5)] to assume original jurisdiction. The commission will

- Meet with church leadership to ascertain what their hopes are for the future of Lochearn
- Conduct a special administrative review of the church records per G-3.0108a-b.
- Conduct a full financial review per G-3.0113 and arrange for payment of any debt that impacts on the church's worship and program
- Make preliminary reports to the Commission on Ministry at its November and March meetings
- Make a final report to the COM no later than May 1, 2026, including a realistic assessment of the congregation's viability and recommendations for the future.

To accomplish these goals, the administrative commission has original jurisdiction [G-3.0303e] in all financial and corporate matters, including access to church rolls, session minutes, financial records, bank accounts and corporate filings. If the work requires specific expertise not available through volunteers within or outside the presbytery, the services of real estate, legal and/or financial professionals can be made available to the commission with the approval of the General Presbyter and the Stated Clerk
