## Report of the Administrative Commission For Covenant Presbyterian Church

Upon the request for dissolution by the congregation of Covenant Presbyterian Church of Hagerstown, Maryland, the Presbytery of Baltimore acting through its Steering Cabinet established an Administrative Commission to attend to any and all matters related to the closing of the church. Appointed as members of the Commission were: Rev. Walter Peters; Rev. Terry Martin-Minich; RE Anita Drummond; RE Bruce Dean; and RE Ed Gilliss.

In keeping with the charges outlined in their commission, the Administrative Commission did the following:

- Met with members of the congregation prior to the dissolution to explain the role of the Administrative Commission
- Assisted in the creation of the closing worship service.
- Following the dissolution, transferred several members to other congregations upon their request; and then provided the Stated Clerk with a roster of any remaining members along with the authority to transfer them to other congregations once the Administrative Commission was dismissed.
- > Transmitted all of the official records of the church to the Stated Clerk to be transferred to the Presbyterian Historical Society.
- Following the dissolution, handled the oversight and management of the church's financial resources, with A.C. members Anita Drummond and Terry Martin Minnich serving as the responsible signatories on church accounts. (Note: even after the AC is dismissed, a final accounting of the church's finances will take place, with any remaining bills being paid, and the church's intentions with regard to legacy gifts being met.)
- Following the dissolution, continued to maintain and secure the property, paying all related costs.
- ➤ Oversaw and/or arranged for various articles of church property, such as fellowship hall tables and chairs, and sanctuary items such as hymnals, the baptismal font and communion table.
- Engaged the William G. Bowen firm to complete an appraisal of the real property
- Engaged the Praise Buildings, Inc. real estate firm to market the property.
- Engaged Fox and Associates to complete a boundary survey of the property as a condition required by the title company prior to sale.
- Acted on offers for the church's real property, agreeing to sell a single lot to one bidder, and the remaining lots and the church buildings to another. In both cases, the sales price met or exceeded the asking price, the sum total of which was \$665,000.

The Administrative Commission wishes to give special thanks to Stated Clerk Mary Gaut for her regular assistance and availability; and to Pam Kries, the Administrative Assistant of Commission member Bruce Dean, whose help in insuring that the various documents needed for each of the two closings on the property were completed and put into the proper hands in order to effect the sales in a timely fashion.

Grateful to God for the ministry of the Covenant Presbyterian Church over the years; and grateful to the members of that congregation who took their membership seriously even as the end of their church's life drew near; and grateful for all those who offered us both guidance and assistance over the course of our work, the Administrative Commission now requests that it be dismissed.

	Status of the membership rolls – Walt will send a letter to Covenant members informing them that
	requests for membership transfers will need to be made to Presbytery
	Church records will need to be assembled and sent to the Presbytery. Anita will take care of this.
	Financial affairs – There are sufficient funds to pay for upkeep and maintenance of the building
	and grounds. Anita will continue to process and pay any incoming invoices. The co-signers of the
	checking account are currently Rachel Sindaco and Anita Drummond. We will remove Rachel's
	name as co-signer and add Rev. Martin-Minnich as co-signer with Anita Drummond. Anita will
	make the arrangements with Fulton Bank.
	Property – The main church door and the kitchen door locks will be re-keyed. Anita will make the
	arrangements. Lawn care will continue, as well as snow removal (on as-needed basis).
	Inspections and maintenance of HVAC and fire suppression/extinguisher systems will continue.
	Thermosats will be set at 55 degrees. Insurance coverage will stay in place. The vacant building is

There are also two churches interested in the property. Walt will contact the property owners to ask if they would like to make an offer and Anita will contact the pastor of New Testament Church of Hagerstown to ask them to submit an offer.
